# BOARD ANNOUNCEMENT

The Board received notice of resignation from one member on August 30, 2022.

In accordance with Association policy the Board will ask members of the community to apply, to fill the open seat.

Applications can be picked up at the Lodge or downloaded from the link in the Happenings.

Applications must be received by September 9th in order to be considered.

The Board will announce a meeting to address the vacancy and choose an applicant to fill the seat.

### FILLING A BOARD VACANCY POLICY

First and foremost, the Board of Directors has a fiduciary duty and obligation to the Community to appoint the best qualified candidate to fill a Board vacancy. To accomplish this, the Board needs to have total discretion, flexibility and latitude in the process.

When the Board receives notice that a Board Member will be resigning, a special Board meeting should be called immediately to determine how that vacancy will be filled. The Board should consider the most expedient manner in which to obtain a full Board.

Unless a Board vacancy is created by the removal of a Director by the Members, the remaining Directors shall fill any vacancy on the Board. In determining who shall fill the vacancy, the Board may take into consideration any or all of the following:

- 1. If willing to serve, a vacancy may be filled from the remaining candidates from the previous Board election in the descending order of votes received.
- 2. If the candidates from the previous election do not want to serve the remainder of the term, candidates will be solicited from the Community to file an application. The application process should be no longer than 30 days. The Board may then fill the vacancy from those eligible members who submitted an application by calling a special meeting as soon as practicable.
- 3. If a tie vote by the Board is encountered in the selection process, the vacancy may be filled by a chance determination, such as a coin toss or high card draw, if all parties involved agree to it. If the candidates don't agree to a chance determination, a run-off election may be held.
- 4. The vacancy can remain open until the next annual election.

Who are those people with the blue name tags??

In March of this year, the Four Seasons HOA Board approved the formation of the Welcome Wagon Club. We thank the Board for their approval and support. We have grown to 16 active members currently. We call ourselves the Wagoneers. We have met with 30+ of the 85 new residents who have moved into Four Seasons during 2021 & 2022. And we hope to meet with more!

During our visits the goal of the Welcome Wagon is to truly connect with new neighbors, talk with them about life here at Four Seasons, answer questions they may have, guide them in settling into the community and help them get acquainted with Palm Springs.

We get questions like: "How do I find a good doctor and vet here in the desert?"

"Do you have cable or dish at your house? Which is best?"

"We want to build a pool. Do you have a good pool contractor?"

"Can you recommend a great weekly pool service?"

"Do you know a good gardener?"

"We understand you guys play pickle ball here. Can we play too?"

"Is it always this hot in the summer?"

"Is it true you play WINE BINGO here?"

"Please, point us in the direction of some really great restaurants."

"What do you mean there aren't any good Chinese restaurants here?"

AND... "OK tell us... How do we go about painting our house??"

We gift new community members with a basket filled with simple household items, lists and information on Four Seasons and Palm Springs, useful Where To Go To information, Vendor Suggestions and sometimes vendor discount coupons when they are available. Each basket has a value of approximately \$20 -\$25 and the costs are all covered by donations from the Wagoneers.

In our new neighbor meetings, we review the clubs and activities offered at Four Seasons and encourage new community members to get involved. We put them in touch with activity and committee organizers to make sure they have all the information they need.

We gently ask questions about their lives before moving to Four Seasons and try to connect them with other residents with similar interests and backgrounds helping them lay foundations to form new friendships.

We offer a list of local businesses and their contact information they are sure to need while settling into their new homes.

We give new community members a suggested list of service providers recommended by current residents that have had good luck in using their services.

The Welcome Wagon Wagoneers have become the official greeters of Four Seasons most popular community event, Saturday's Coffee & Chat, helping to introduce and connect new community members with longtime residents.

You will usually see us at most community events, wearing our name tags and chatting people up as we try to break down the challenges of being the new kids who don't know anybody, and we encourage them to get involved.

The Four Seasons Community is filled with fascinating people who have built great lives, raised families, had successful careers and are very accomplished impressive individuals. Most will tell you their lives required some effort to achieve it all, but that you get back from it – what you put into it.

We encourage all Four Seasons residents to put a little effort into their life here in the community. Reach out to neighbors. Join a club. Participate in an activity. Help new community members settle in and assist long time neighbors with their special needs and projects. Watch the quality of your life here in the community grow into a fun and fulfilling life chapter. You can only expect a return on investment based upon what you put into it!

When you see a Welcome Wagon Wagoneer with their blue name tag and the year they moved into Four Seasons, stop, and say hello. Introduce yourself. Let them know how long you've lived here. Start a conversation. It's likely to lead to fun and new friendships!





### Introducing Joan Lazarus



Who would have thought that having a dedicated dance studio room would be the impetus for someone to relocate to our Four Seasons community? Our community is just so lucky to have that be true. It (along with a few other factors) has brought us Ms. Joan Lazarus, whose talent, education, grace, passion, and dedication is simply amazing. We are going to be so fortunate to experience all this in December. But I am getting ahead of her story.

Joan and her twin sister grew up in the Boston area where their father was a renowned scientist at MIT. She began ballet dancing at a very early age and has never stopped. Along with dancing and a first marriage, she obtained a B.A. in Psycholinguistics which is a field of study encompassing the structure of speech as it is decoded by

the brain. Then she obtained an M.A. in Dance and another M.A. in Arts Administration.

Her dancing career has taken her from coast to coast as well as on national tours. The emphasis was on ballet but very soon her interest turned to modern dance. And a time at the University of Oregon where she encountered a magnificent instructor and mentor led her to teaching dance. This then led to executive and directorial positions in the Bay area - with the Oakland Ballet, the Cowell Theater, the San Francisco Ballet Associate, the Citicentre Dance Theatre (Oakland) all the while performing and teaching. You can see the juxtaposition of her education in the scientific field and her dancing has meshed nicely. Suffice it to say that she has spent some 25-30 years pursuing her passion and it continues to this day. She has danced with or appeared in the works of a long list of famous dance artists as well as being on the faculty (full-time) at the University of Oregon and Mills College, teaching at San Francisco Ballet, The Princeton Ballet and other dance venues. She has received numerous awards including but not limited to the Isadora Duncan Dance Award for Sustained Achievement. When she talks about teaching dance, there is a very striking sparkle in her eyes and an excitement in her voice. One simply gets transported to the beauty and joy of movement right alongside her.

Along the way, after a blind date, she married for a second time and became stepmom to two children aged 8 and 12. Unfortunately after some 12 years, that marriage ended with Joe's demise.

It is our good fortune to have Joan living here on our west side along with her colleague and partner, Rob Bailis. Rob is currently still working full time as the Director and Arts Administrator of the Broad Stage (Santa Monica), He is also a clarinet virtuoso



and performs at various venues.

Joan's teaching brought her to leading a class at our Mizell Center where the specialty was Ballet for Older Dancers. She is interested in continuing that here at our own Lodge should there be any interest. The emphasis will be on strength and balance, and it is not required that a student be professional – just someone who might love to dance and was perhaps told at some point, that was not their forte. You may recall from previous profiles that a free program of live performance and talent is being produced by residents Michael Roberts and Kay Montgomery. To everyone's delight, Joan has agreed to step up and produce alongside them. # Need More People to Wine By Ross Willour

Let's promote more resident wining! If you've never been to a Wine Club social that happens on the 2<sup>nd</sup> Thursday of each month, considering checking it out. We'd really be pleased to have you there. If you already know quite a bit about wine, you'll enjoy it. But if you just like wine and wonder if you'd like to know more about it, you too will enjoy the get together. In other words, you don't have to be oenophile; don't be at all intimidated about coming whatever your level of wine knowledge. And as a newcomer, you needn't bring anything except the glasses you want to use!

Blind taste testing and socializing. Here's an example of what happens at one of our socials. For our March meeting, participant Jim Martin volunteered to do a brief talk on Riesling wines. I send out an email to people on our list in advance of the meeting to let them know the type of wine to be featured that month. If you are a newcomer, I am happy to send you the email if that interests you; just reach out to me at <a href="mailto:rwill6462@aol.com">rwill6462@aol.com</a>. However, no worries if you wish to just show up without getting that email beforehand.

Jim let the 21 people in attendance know that: Riesling is an aromatic white grape variety that is native to Germany; it is also commonly found in France, Australia, and the United States; there a range of styles from bone dry to sweet desert to sparkling; and Riesling is one of few white wines that can age for decades and can pair with all food types.

We had six bottles volunteered for the blind evaluation which everyone independently rated for Appearance, Aroma, Body, Taste, and Finish. No worries if you don't know what these traits mean because we'll explain them.

Each bottle can attain a total of 25 points. The final scores (an average of everyone's ratings for each bottle) were: first place with 19.8 points was Dr.Heblemanus Bernkastel; second place with 19.4 points was Barefoot Cellars; third place with 18.9 points was

Kendall Jackson; fourth place with 17.9 points was Chateau Ste. Michele; fifth place with 17.7 points was Renew Mosel and sixth place with 17.4 points was A to Z.

The group had fun chatting about how the ratings turned out. One intriguing pattern over the years has been a weak relationship between the prices of the wines and the ratings they get; for example, there have been times when the least expensive bottle got the highest score! After the short group discussion, we shifted to our social time with snacks, other bottles of Riesling, and hearty conversation. Until COVID, we also had a nice dinner with wine pairings once a year, using \$2 that regulars donate each month for that purpose; we hope to relaunch that annual event in the coming months. To close, I remind you of our bottom line; we hope more people in Four Seasons will wine with us!

The 9th Annual Four Seasons Bazaar will be held on **Saturday, November 12, 2022**. In conjunction with this event, there will be a mini-rummage sale.



### Middle Class Tax Refund

<u>Overview:</u> The Middle Class Tax Refund is a one-time payment to provide relief to Californians.

If you are eligible, you will automatically receive a payment. Payments are expected to be issued between October 2022 and January 2023.

Eligibility: You are eligible if you:

Filed your 2020 tax return by October 15,

2021,

Meet the California Adjust gross income (CA AGI) limits described in the What you may receive section,

- Were not eligible to be claimed as a dependent in the 2020 tax year,
- Were a California resident for six months or more of the 2020 tax year,
- Are a California resident on the date the payment is issued.

### When you'll receive your payment:

Californians are expected to receive payments between October 2022 and January 2023.

### How you will receive your payment:

Generally, if you filed electronically and received your 2020 tax refund by direct deposit, then you should get your payment the same way. Otherwise, you will receive your payment on a debit card.

### What you may receive:

For your CA AGI, go to Line 17 on your 2020 Form 540 or Line 16 on your 2020 Form 540EZ.

You can find specific tables of what you will receive based on the above information on the <u>California Franchise Tax Board</u> website but payments will generally be between \$350-\$1,050.

## Spectrum Survey Results

[Board Action on August 25: Based on the survey results, the Board has asked the Association's Ad Hoc Technology Committee to seek offers from one or more additional vendors and to negotiate potential improvements in the offer from Spectrum.]

### About the survey and this report

Prior emails not designed to systematically elicit representative community views. The first email sent to residents can be regarded as an informal query (or survey). However, it was not intended or designed to elicit systematic, large-scale information from residents. Rather, the email merely invited residents to suggest questions or offer comments or concerns only for the purpose of informing development a formal survey. Further, that email did not ask each resident to send in their views and it also stated that a formal survey would be forthcoming; this statement would make many of the email readers feel it was not necessary to send in their views or comments at the time of the initial email, because they would be given an opportunity to do so in the planned, upcoming survey. Therefore, comments sent in as replies to the first email are not systematically representative

of the community's sentiments; obtaining such views is the purpose of the recent survey.

One response per household. The survey instructions asked that only one survey response be submitted per household. Therefore, the survey software parameters were set to permit just one submission per device; that is, if a user entered the survey again on the same computer after previously submitting a response, it did not make the survey available to the user. It was possible, however, for a household to disregard the honor system and enter more than one response by using different electronic devices to complete the survey


This FOCUS article is an adaptation of the Executive Summary of a technical survey report provided to the Board. I found that residents' written statements in the survey really helped me clearly understand my friends' and neighbors' varied questions, thoughts and feelings about this matter.

### Results

A strong majority (70%) of survey-takers are interested in the Board pursuing a bulk services agreement with Spectrum. Most of the survey respondents (92%) were current Spectrum users. While



Spectrum households generally said "yes" and non-Spectrum households generally said "no," there were exceptions among both groups.



There is an uncommonly high degree of confidence that this result is representative of views in the community, because the 348 received responses correspond to almost three-quarters (73%) of Four Seasons households; [As a comparison, even elections for the Board typically receive a response from less than half of Four Seasons households.]

There are three caveats about the overall result, as described below. However, because the frequencies of the caveats are relatively low, they do not mathematically rise to the level of altering the overall finding that a majority of respondents are interested in the Board pursuing the agreement.

First, write-in comments suggest that some residents had not seen and/or understood some specific key points in the previously provided information, particularly the Spectrum TV channel line-up and the cost of add-on services that residents might currently have or want beyond those included in the bulk services agreement. Not being aware of this information could have influenced some responses. This finding suggests that additional efforts should be made to communicate information and answer questions. Second, about 4% of respondents said no, but also that they still are considering this issue. Third, about onefifth of "yes" respondents have reservations about their preference, most often out of concern for the impact on non-Spectrum households (rather than concerns about the value of the agreement for their own household).



Most respondents took time to write comments. Over a hundred "yes" respondents remarked enthusiastically about the cost savings, and other "yes" respondents commented on a favorable prior experience with Spectrum bulk services when they lived in other HOAs.

Among the "no" respondents, the most common written objections or concerns included: bad prior experiences with Spectrum retail services; losing some TV channels they currently have, because they are not in the Spectrum lineup; a stance that an Association requirement that delves into residents' consumer choices is inappropriate; or wondering about the impact of higher HOA dues on homes' marketability.

Some "no" and "yes" respondents shared some reservations about proceeding.

- The most common concern was a worry about or objection to requiring non-Spectrum households to pay for Spectrum in their HOA dues if they did not wish to subscribe. Among these respondents, most were concerned about converting from another carrier.
- However, other respondents were concerned that they already have or would want, within the period of a five-year contract, to move to streamingonly TV services.
- Other shared points of view were about a sense of unfairness for Spectrum and/or the Association Cable is dying. I prefer streaming and mobile access to internot to address out-of-pocket costs for initial conversion, including: termination penalties in existing agreement with other providers or buy-out costs over the remaining life of an agreement (if no termination permitted); and the charge for inhome Spectrum installation.
- Also, some respondents felt the agreement would be unfair for people who do not reside here yearround, unless it would be possible for them to suspend or not pay for the service when away for substantial periods of time, which customers currently can do in their retail agreements.

Following are a few comments written by respondents, selected to illustrate each point in this article.

I'm very excited about the savings! (Over 100 similar write-in comments)

Every place I've lived in this millennium, I've lived with a bulk rate internet and cable provider. I was shocked when moving into the 4 Seasons there WASN'T a bulk rate provider. When Spectrum quoted the price of service for our home, I almost pooped my pants!

Some residents say they don't use and don't want to be forced to pay for it. However, they are not allowed to cafeteria pick what other items the HOA dues cover like recreation facilities they don't use. Plus, they must not be aware of how Four Seasons' dues are one of if not the lowest in the Valley, especially for a neighborhood this size.

I would be getting channels I do not ever watch and lose those that I do watch all the time.

Some of us have contracts with other providers already and breaking them would result in fees that we have to pay. I would be charged for a cable service I chose not to use just so others would get a discount.

As a seasonal homeowner, Spectrum offers temporary cessation services for \$5/mo. Request this feature be included in any new plan.

I don't want to contribute to a monopoly with such a poor history of horrible treatment of customers.

net. I do not want to be committed in a contract that is five years long to a product that has limitations, in a time that technology is changing so rapidly.

The HOA should NOT be interfering in the finances of homeowners' private consumer choices.

Advertising HOA dues at higher rate when selling home may discourage buyers.



### \* It's That Time of Year \* Submitted by Tom Perdue

The Finance Committee is now working to deliver its 2023 operating, capital, and reserve budget recommendations to the Board of Directors. The Finance Committee has already conducted two budget workshops and expects two more before submitting its 2023 plan to the Board. This year is even more challenging than last year due to continuing high inflation's impact on our HOA cost structure.

We, the residents, are the HOA, the shareholders. The operating budget funds keeping the lights on, managing, and maintaining the property and its activities. The capital budget funds new items such as the recently acquired alarm systems that have been installed at the East and West pool areas. Reserve funds are essentially a savings account that are used to pay for longer- term repairs and replacement such as the pools, street repaving, etc.



Reserves are fully (100%) funded when the reserve funds balance is equal to projected cost, determined in a detailed independent reserve study done each year. Special assessments are levied when a HOA reserve is underfunded relative to a necessary major repair or replacement.

We are fortunate that over the years our HOA has achieved and exceeded full reserve funding. I recently read that the average California HOA is approximately 60% reserved. Our reserve strength greatly mitigates the risk of special assessments which are particularly disruptive to retirees living on a fixed budget.

Last year, to hold the monthly assessment increase to 7% (in a +8% inflation economy) the monthly allocation to reserves was reduced by \$5,000. During the year, several large projects including the pool and security camera replacements have been funded from reserves. Smaller contribution and significant expense results in our current reserve funding level of 97%.

The Finance Committee and the Board must build a budget that balances operating, capital, and reserve needs. A critical question is at what level should reserves, our savings account for the future, be maintained? The sum total will ultimately determine 2023 monthly assessments.

We are all experiencing the challenges of the current economy within our personal lives – our HOA is not immune from the same pressures. The goal, however, remains the same: maintain a safe, financially strong, active community that contributes to the market value of shared assets and properties.

A perfect storm of comedic proportions erupts in a DC bookstore over the course of one soggy summer


An invigorating blend of history and journalism informs this journey down Old Man River...Besides being a willing and intrepid traveler, Buck is also an able interpreter of history,

# You May Be Able to Pay Less for Internet Access or Even Get it Free



Internet access is necessary for work, school, healthcare, and more. Unfortunately, high speed internet remains unaffordable for too any households. The Federal Communications Commission (FCC) runs a program, the Affordable Connectivity Program (ACP), that reduces the cost of getting online for people with limited income. Many internet providers offer fully covered internet plans—meaning you may even get high-speed internet for free.

If your household income is 200% or less than the Federal Poverty Guidelines or someone in your household participates in certain ACP provides. Visit the ACP website to see if you qualify. Please do not contact Social Security with questions about the ACP.

You can take advantage of the discounts with confidence knowing that receiving ACP assistance does not affect your Social Security retirement, survivors, or disability benefits.

### What discounts are available?

- \$30 per month toward internet service for eligible households. Some companies offer internet service for \$30, making internet service free.
- \$75 per month for households on qualifying Tribal lands.
- Eligible households also can receive a one-time discount of up to \$100 toward purchasing a laptop, desktop computer, or tablet from participating providers.

## **Getting from** Here to

Wow. By late fall, you'll be able to fly nonstop from Palm Springs to 35 different cities! It's been slim pickings during the summer, as usual, with only 16 routes operating. However, during September through December (especially in November), airlines are adding back seasonal routes to many more places: three routes resume in September; four of them in October; 17 routes return in November; one in Dec; and five sometime this fall (TBA, Allegiant).

Admittedly, the main market for many seasonal flights is to bring people to sunny Palm Springs for winter getaways, because we're less apt to leave here and go there in winter; for example, three different airlines are serving the chilly city of Edmonton in northern Alberta. On the other hand, maybe you have friends or relatives in these climes who could use the flights to visit you more easily!


On August 4, the airport announced the addition of budget carrier Avelo, beginning in November. This brings the number of airlines serving PSP to 13! Avelo is including nonstop service to two new cities for Palm Springs: Bend/Redmond and Santa Rosa. Below is the complete list of airlines and destinations, drawn from information on the airport's website. Note that the site does not specify the frequency of flights, i.e., while most routes operate daily, some only operate several days of the week, or even one day a week. You'd have to go the airline's websites to determine this.
